The property is situated in one of Irthlingborough's most popular residential areas with High Street shops and amenities close by. Benefits include gas radiator central heating, uPVC double glazing and offers a cellar, two double bedrooms and communal parking bays. Please note the property would benefit from further upgrading and refurbishment. The accommodation briefly comprises entrance hall, lounge, sitting room, kitchen/breakfast room, cellar, landing, two bedrooms, bathroom, front and rear gardens, outbuilding and outside W.C.
