


Situated in the popular town of Raunds is this immaculate and well proportioned modern three bedroomed semi detached property featuring a 15ft x 11ft kitchen/dining room with integrated appliances, an en suite shower room to the master bedroom and double width off road parking for two cars. Further benefits include gas radiator central heating and uPVC double glazing. The accommodation briefly comprises entrance hall, cloakroom, lounge, kitchen/dining room, three bedrooms with en suite shower room to master, bathroom, rear garden and off road parking.


