Offered with no upward chain and situated near the historic St Peters Church is this mature bay fronted two bed roomed mid terraced property featuring character features to include sash windows and original fireplace to bedroom one. The property is in need of significant refurbishment and would benefit from new kitchen, bathroom, central heating redecoration and re-carpeting. The accommodation briefly comprises entrance hall, lounge area, dining area, kitchen, landing, two bedrooms, bathroom and a rear garden.

Entrance Hall

Stairs rising to first floor landing, telephone point, door to:

Lounge/Dining Room

Lounge Area

Window to front aspect, wall mounted gas fire with tiled surround, telephone point.

Dining Area

Sash window to rear aspect, cupboard to chimney breast recess, wall mounted gas fire with brick surround, under stairs storage cupboard, door to:

Kitchen

11' 1" x 5' 9" (3.38m x 1.75m)(This measurement includes area occupied by kitchen units)

Fitted to comprise stainless steel single drainer sink unit with cupboard under, a range of eye and base level units providing work surfaces, tiled splash backs, part glazed door to side aspect, window to side aspect, built-in oven, gas hob, fridge/freezer space.

Loft access, storage cupboard, doors to:

Bedroom One

Two single glazed sash windows to front aspect, character fireplace, built-in cupboard to chimney breast recess, wall mounted electric heater, T.V. point.

Single glazed sash window to rear aspect, wall mounted electric storage heater.

Bathroom

11' 2" max. x 5' 8" max. (3.4m x 1.73m)

Fitted suite comprising of low flush W.C., vanity sink with cupboard under, panelled bath with shower over, tiled splash backs, wall mounted gas heater, single glazed window to rear aspect, water cylinder.

Outside

Rear - Block paved yard area, further brick outbuilding with outside toilet housing low flush W.C., shared pedestrian access to rear, enclosed by wooden panelled fencing. The rear garden is mainly paved with bushes and in need of some cultivation.
