Situated in a no through road is this mature bay fronted two/three bedroomed mid terraced property with benefits to include gas radiator central heating, uPVC triple glazing, re-fitted kitchen, re-fitted downstairs bathroom and offers an 80ft rear garden and two double bedrooms with further single bedroom/study via bedroom two. The accommodation briefly comprises porch, lounge, kitchen/breakfast room, kitchen, down stairs bathroom, two/three bedrooms, fore court and rear garden.
