


Obelisk Road Finedon

Benefits include gas radiator central heating, uPVC double glazing and offers three good sized bedrooms, a garage in a block to the rear and a rear garden enjoying a south westerly aspect. The accommodation briefly comprises entrance hall, lounge, kitchen/dining room, rear lobby, landing, three bedrooms, bathroom, separate W.C., front and rear gardens, garage to rear in a block. Please note there is potential for off road parking at the end of the garden subject to the necessary permissions.

Front - Mainly gravelled with central flower bed stocked with rose bushes and shrubs, enclosed by brick walling and wooden panelled fencing.

Rear - Comprising main lawn with border stocked with bushes and shrubs, wooden shed, potential off road parking to the end of the garden subject to the necessary permissions, garden enclosed by timber panelled fencing. The garden measures 49ft at it's deepest point and enjoys a south westerly aspect, gate to:

Single garage - Situated in a block to the rear of the property with up and over door, power and light connected.
