Offered with no upward chain and situated at the end of a cul de sac is this modern three bedroomed semi detached property with benefits to include uPVC double glazing, gas radiator central heating, built in kitchen appliances and offers off road parking for up to three cars however the property would benefit from some re-decoration and re-carpeting. The accommodation briefly comprises entrance porch, cloakroom, lounge, kitchen/dining room, three bedrooms, bathroom, front and rear gardens.
