


Offered with no upward chain is this beautifully presented three/four bedroomed detached property situated within a popular cul de sac location and extended to provide a generous sized utility room and converted garage offering a fourth bedroom with en suite shower or home office. Further improvements include refitted kitchen with integrated appliances and quartz worktops, refitted sanitary ware throughout, replacement uPVC windows and doors, replacement internal doors and offers off road parking for at least three cars and a rear garden enjoying a private aspect from the rear and backing onto a wooded area. The accommodation briefly comprises entrance porch, cloakroom, lounge, kitchen/dining room, utility room, three bedrooms with en suite shower room to master, bathroom, front and rear gardens, converted garage -Home office/bedroom four with en suite shower room, and a driveway.


