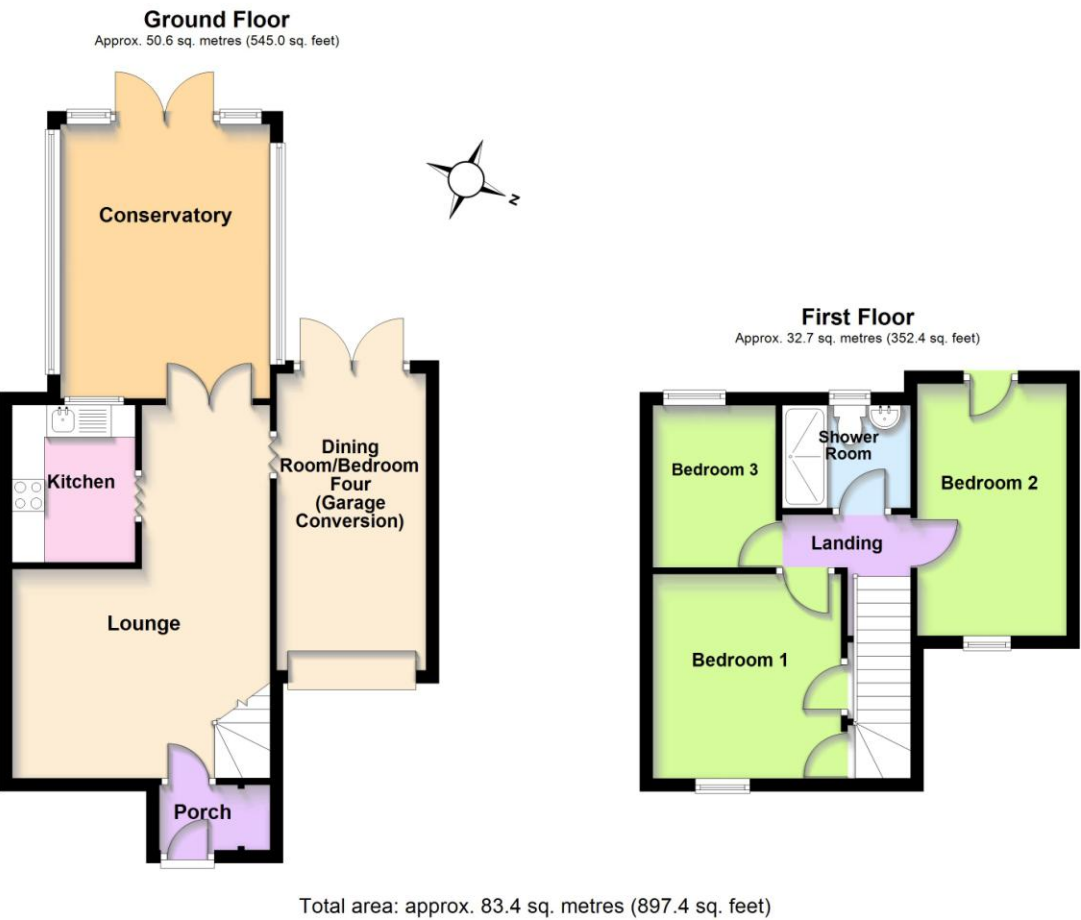

Further benefits include gas radiator central heating, uPVC double glazing, refitted shower room and offers off road parking for one car and a recently landscaped low maintenance rear garden. The accommodation briefly comprises porch, lounge, kitchen, conservatory, dining room/bedroom four, first floor landing, three further bedrooms, shower room, front and rear gardens and a driveway.

Front - Garden is mainly blocked paved with gravelled raised border, enclosed by dwarf walling, blocked paved driveway providing off-road parking for one car.

Rear - Recently landscaped and of low maintenance design being mainly paved with rustic wooden decking and seating, wooden shed, garden is enclosed by wooden panelled fencing and brick walling.
