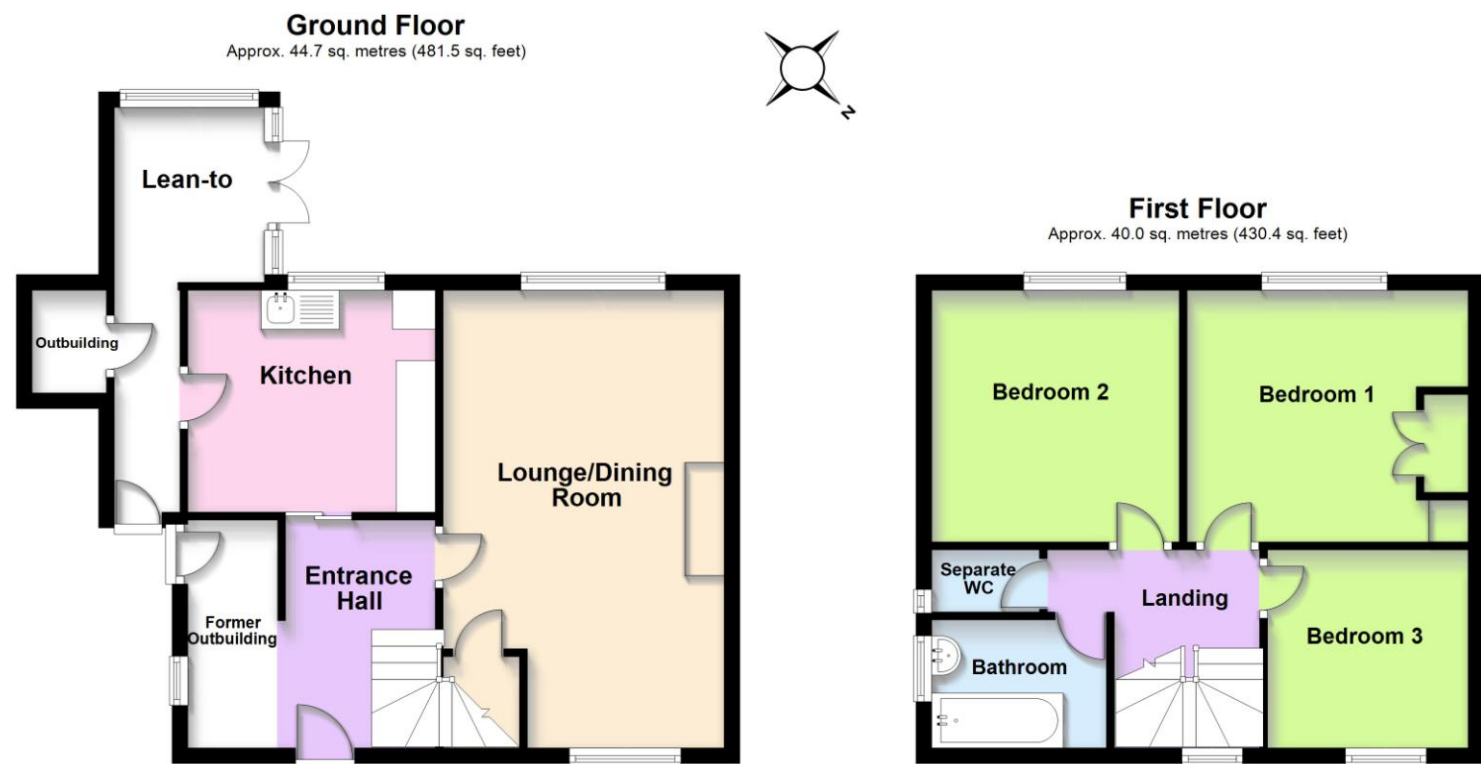

In need significant refurbishment and offered with no upward chain is this established three bedroomed semi detached property situated in the popular town of Finedon just off Oxford Street. The property has uPVC double glazing fitted and offers three good sized bedrooms and a 47ft rear garden. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, three bedrooms, bathroom, separate W.C., front and rear gardens and a lean-to.

Entrance Hall

Stairs rising to first floor landing, window to side aspect, power points and further door to side. access to former external outbuilding, wall has been partially removed measuring 9' 4" x 3' 7".

Lounge

19' 3" x 12' 0" max (5.87m x 3.66m)

Windows to front and rear aspects, under stairs storage cupboard, solid fuel fireplace in need of replacement.

Kitchen

9' 4" x 10' 4" (2.84m x 3.15m)

In need of replacement presently comprising of stainless steel single drainer sink unit with cupboard under, further eye and base level units providing work surfaces, tiled splash backs, window to rear aspect, door to side aspect, space for cooker, plumbing for washing machine, gas cooker point.

Comprising high flush W.C, tiled splash backs, window to side aspect.

Front - Garden is in need of some cultivation, enclosed by privet hedge.

Rear - Garden is in need of cultivation, brick storage barn, timber lean to measuring 7' 4" x 6' 8", door to front aspect, of wooden construction with glazed windows and French door to garden. Enclosed by wooden panelled fencing and wire mesh, measuring approximately 47ft in depth.
