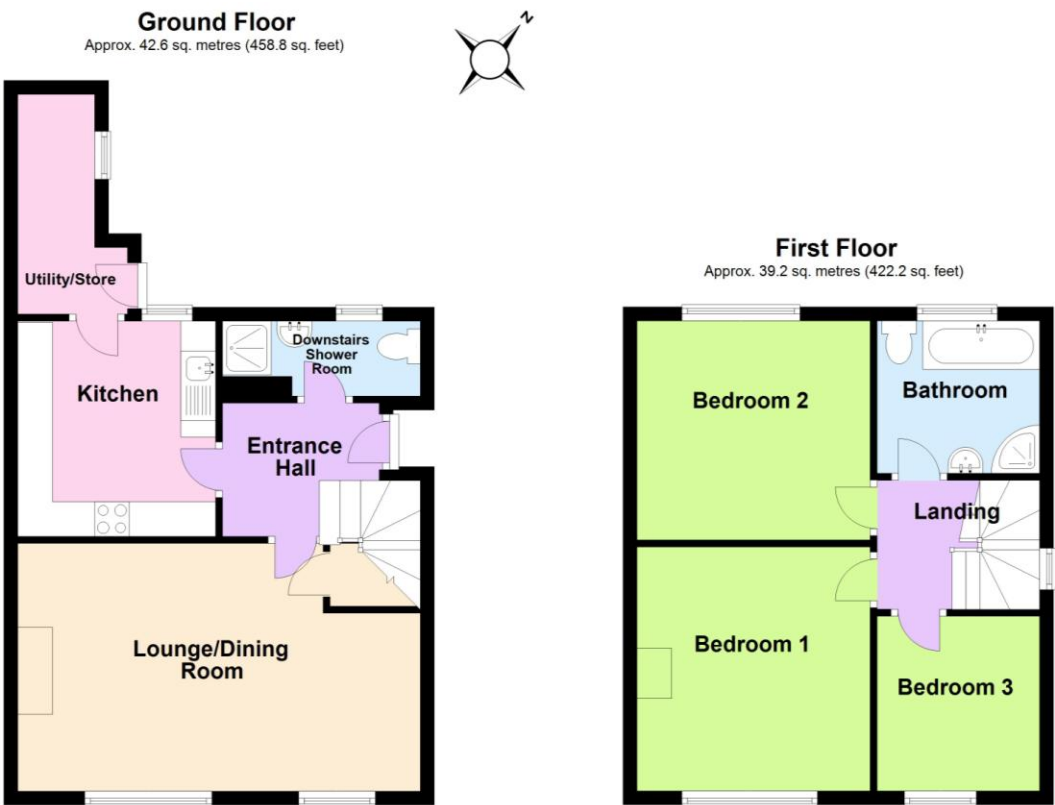

Situated in a cul de sac off Oxford Street is this established three bedroomed semi detached property with benefits to include gas radiator central heating, uPVC double glazing, modern four piece bathroom and offers double width off road parking for two cars and three good sized bedrooms. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, utility/store, down stairs shower room, three bedrooms, bathroom, rear garden and a driveway.
