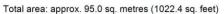

Offered with no upward chain and set back from Victoria Street is this attractive bay fronted two bedroomed mid terraced property offering generous living space of approx. 1022 square feet with the added benefit of a single garage to the rear with off road parking for one small car. Further benefits include gas radiator central heating, a mixture of uPVC and sealed unit wooden framed double glazing and offers a 27ft lounge/dining room, a 19ft kitchen/breakfast room, two double bedrooms and a 52ft rear garden. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen/breakfast room, rear lobby, cloakroom, landing, two bedrooms, bathroom, front and rear gardens, single garage and off road parking.
