LOCATION

ENTRANCE HALL

22'0 x 4'6 (max)

A private entrance door opens into a welcoming hall with doors leading off to a cloaks/storage cupboard, loft access, both bedrooms, the living room, and the shower room. There is also an intercom system and a radiator.



LIVING ROOM

12'7 x 15'3

A bright and spacious living area featuring a radiator, a dormer window with an integrated blind to the rear elevation, and an additional skylight with an integrated blind, also to the rear. The room opens through to the kitchen.

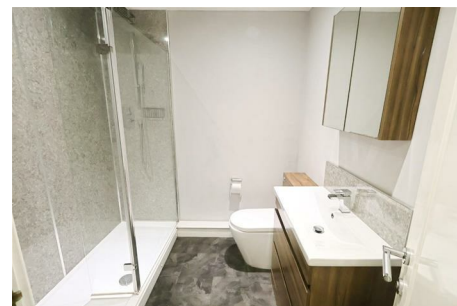


KITCHEN

8'9 x 9'3

Fitted with a modern range of gloss-fronted wall and base units with wood grain effect work surfaces, housing a stainless steel single drainer sink unit with mixer tap. Integrated appliances include an oven, hob, and stainless steel

extractor hood. There is a cupboard housing the gas combination boiler, along with space and plumbing for a washing machine. A dormer window faces the rear elevation.



SHOWER ROOM

7'5 x 6'3

Installed with a contemporary white three-piece suite comprising an oversized shower enclosure with panel walls and a dual-head thermostatic shower with glass screen. There is a vanity unit with an oversized wash hand basin and waterfall-style mixer tap, an integrated dual-flush low-level WC, a wall-mounted cabinet, and a chrome heated towel rail. Recessed downlights and an extractor fan complete the modern finish.



BEDROOM ONE

11'3 x 10'4

A well-proportioned main bedroom with a dormer window facing the front elevation, a built-in double wardrobe with sliding doors, a radiator, and access to storage space.



BEDROOM TWO

11'2 x 7'6 (max)

A comfortable second bedroom with a skylight featuring an integrated blind and a radiator, overlooking the front elevation.
