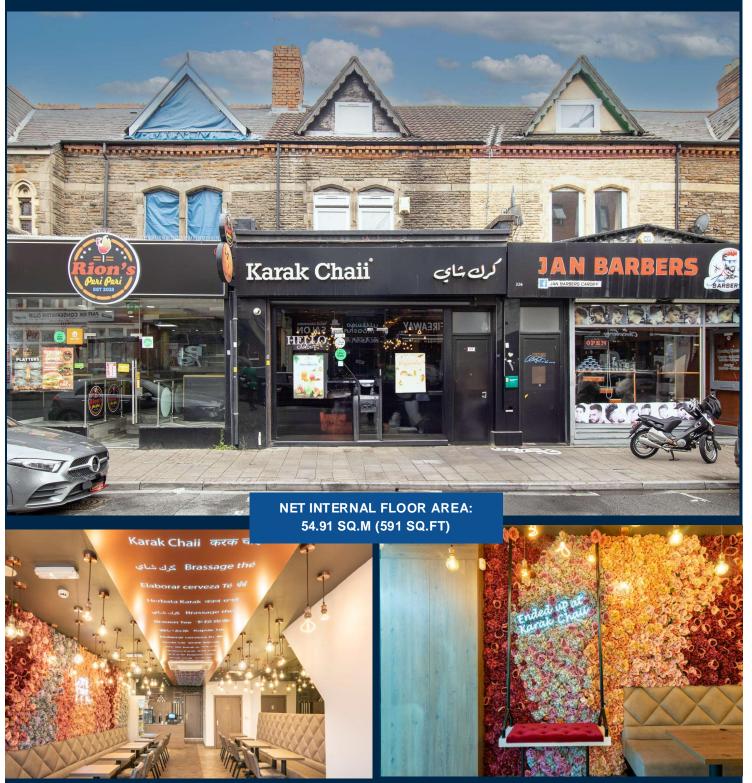

LANGUARK INFORMATION Plotted Scale - 1:5000. Paper Size – A4





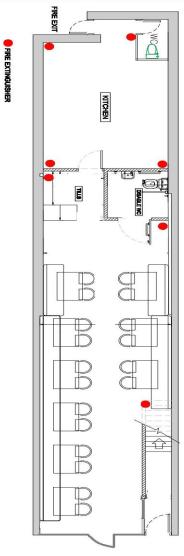


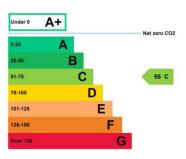
