Offering ample off-road parking with a driveway and garage, this property stands on a sizeable plot with a private rear garden that offers a beautiful retreat, especially in the warmer months.

To the ground floor, the property in brief compromises an entrance porch, dining room, large lounge, hallway, fitted kitchen, a double bedroom, a downstairs shower room and a conservatory.

To the first floor there is a large shower room and a second bedroom that is also double in size.

Carrying a beautiful natural lighting throughout, there is also the additional benefit of double glazing and gas central heating. We recommend an early viewing to be essential in order to appreciate the space and accommodation available.

Entrance Porch

Vinyl flooring and central heating radiator.

Entrance Hallway

Central heating radiator, storage cupboard and laminate flooring.

Lounge

Double glazed bay window to front elevation, double glazed window to side elevation, two central heating radiators, carpet, gas fire and stairs to first floor accommodation.

Dining Room

Double glazed bay window to front elevation, central heating radiator, laminate flooring, electric fire and cupboard housing meters.

11' 2" max x 9' 8" max (3.40m max x 2.95m max) Double glazed door to side elevation, a range of wall and base units with work surface over incorporating a sink with drainer unit, integrated oven and grill, four ring gas hob, extractor hood, tiling to splash prone areas, plumbing for dishwasher, central heating radiator, vinyl flooring and central heating boiler housed.

Double glazed window to side elevation, W.C, wash hand basin, shower cubicle, heated towel rail, vinyl flooring.

Conservatory

Double glazed window to side elevation and carpet.

Double glazed window to side elevation, W.C, wash hand basin with storage, shower cubicle, central heating radiator, vinyl flooring and spotlights.

Front Garden

Half gravel and half tarmac driveway providing off road parking and access to garage.

Rear Garden

Patio area, laid to lawn, gated side access to frontage, steel shed, summer house, brick built outhouse with electrics.

Courtyard

Artificial lawn and outside tap.
