Paved driveway providing off road parking.

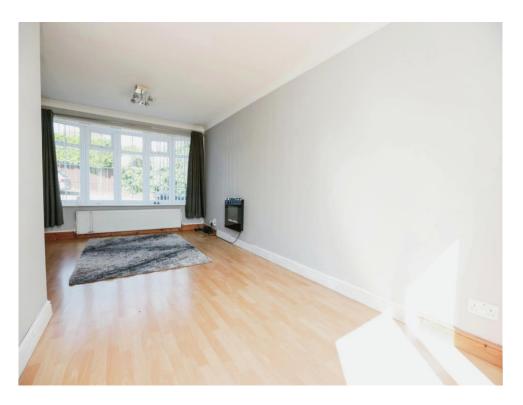

Decking, laid to lawn, plants and shrubs.









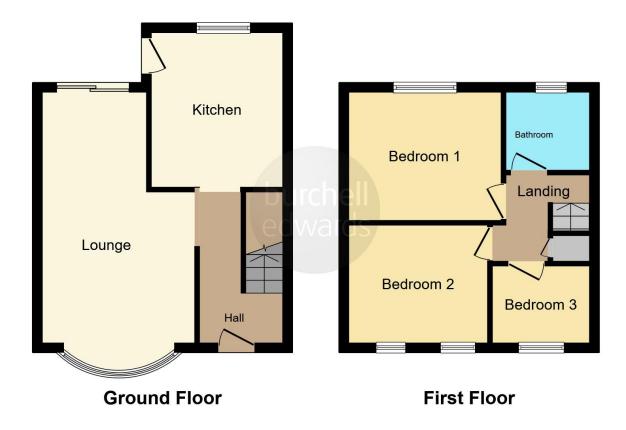
