Lounge

13' 2" $\overline{\text{Max}}$ into chimney breast x 11' 4" (4.01m $\overline{\text{Max}}$ into chimney breast x 3.45m)

Accessed via UPVC door to the front elevation leading into the lounge with carpet flooring, a radiator, ceiling light, coving and UPVC window to the front elevation.

Inner Hallway

Having carpet flooring, understairs storage cupboard and access to the dining room.

Dining Room

13' 1" $\overline{\text{Max}}$ to chimney $\,$ x 12' 10" (3.99m $\overline{\text{Max}}$ to chimney $\,$ x 3.91m)

Having carpet flooring, a radiator, picture rail, ceiling light, coving and UPVC window to the rear elevation.

Kitchen

9' 2" Plus door recess x 6' 11" (2.79m Plus door recess x 2.11m)

Having matching wall and base units with work surfaces over, inset sink and drainer with mixer tap over, splashback tiles, ceiling light, vinyl flooring, a radiator, UPVC window to the rear elevation and UPVC door to the side elevation.

Having carpet flooring, a radiator, ceiling light, loft hatch and UPVC window to the rear elevation with views over open fields.

Bathroom

Having a bath with shower over, low level W.C, wash hand basin, a radiator, splashback tiles, ceiling light, cupboard housing the boiler, vinyl flooring and UPVC window to the rear elevation.

Front

To the front of the property is a courtyard area with low stone wall with a gate.

Rear

To the rear the garden has a patio area, a laid lawn section and a brick outbuilding with store room and W.C.
