

Dropped kerb leading to a Cotswold stone driveway providing off road parking, shared access to the rear and pathway to:

#### **Entrance Hallway**

Staircase rising to the first floor landing, central heating radiator and door to:

## Lounge

15' 9 " into bay x 11' 9 " into recess ( 4.80 m into bay x 3.58 m into recess )

Double glazed bay window to front elevation, central heating radiator, wood effect laminate flooring, built-i under stairs storage and door to:

#### Kitchen

14' 10" max including dining room x 29' 7" max including dining room ( 4.52m max including dining room x 9.02m max including dining room )

A range of Wren Milano wall and base units with Walnut work surface over and soft close doors, incorporating a Belfast sink with mixer tap, built-in oven, gas hob with extractor, glass cooker splashback, tiling, microwave oven, space for fridge/freezer, integrated washing machine, feature vertical radiator and door to:

## **Dining Area**

Lantern style ceiling with aluminum framed UV reflective blue glass windows, double glazed window to side elevation, full width toughened glass Bi-fold doors to rear elevation, tiled flooring, feature central heating radiators, smart meters and Hive heating system.

White suite to comprise of wash hand basin with vanity storage, feature wall and floor tiling, low flush W.C, feature central heating radiator, obscure double glazed window to rear elevation and walk-in shower cubicle with hand held attachment and overhead rain plate.

#### **Bedroom Three**

7' 6" x 9' 3" ( 2.29m x 2.82m )

Double glazed window to rear elevation and central heating radiator.

#### Rear Garden

Paved patio area, raised plant beds, artificial lawn, rear decked area patio area, studio access and fencing to boundaries.













