Location

The Bar Lane Industrial Estate comprises a substantial c.8-acre site close to Western Boulevard (A6514), Nottingham's ring-road. The Estate has two points of entry, the first off Bar Lane and a secondary access from Whitemoor Road. Bar Lane connects to Nuthall Road (A610) which eventually leads to Junction 26 of the M1 Motorway. Western Boulevard is less than one mile from the Estate.

The Bar Lane Estate is located approximately 3miles to the west of Nottingham City Centre.

Description

The site comprises a series of industrial units positioned within an 8acre site. Originally constructed in the 1900's the principal unit has been sub-divided to create approximately 25 units with several other units having been developed since the original. The main structure comprises a northlit roof and traditional solid brick construction inkeeping with the period. Each unit is unique in configuration having roller shutter access and three phase power.


