# Location

The property is located on Barker Gate at the heart of Nottingham's Creative Quarter, circa 0.5 miles from Old Market Square. The Creative Quarter is home to Nottingham's niche shops, bars, and restaurants as well as a multitude of period buildings, many of which have been converted to office accommodation.

The property benefits from superb transport links; the A60 links to Nottingham's Southern Relief Route as well as Nottingham's northern conurbations, the lace market car park and NET - Nottingham's award-winning Tram Service - lie within a 5-minute walk.

Nearby occupiers include; Anoki, Bunk, Nottingham College and Annie's Burger Shack.


