Location

The site is located at the intersection of Nottingham Road and Lincoln Street in the popular residential area of Basford. Basford is an area lying approximately 2.5 miles North-West of Nottingham City Centre and 500m from Western Boulevard (Nottingham's ring-road).

The site is well located for the Hospitals / local amenities and for easy access to the NET tram stop approximately 400m to the North, the tram provides fast convenient access to Nottingham City Centre.

Description

The site is approximately 0.51 acres and currently comprises an array of commercial buildings and a detached dwelling. Fronting Nottingham Road is a three storey building, formerly a bank, but more latterly used for Residential purposes. In addition, the there is a detached dwelling and access to a workshop to the rear. Access to additional accommodation is from Lincoln Street.

Planning permission has been granted for the erection of a new build block of apartments. For 30 Apartments (4 \times 1 bed, 25 \times 2 bed, 1 \times 3 bed) with 1 retail unit also with the former bank to remain, providing more space available to be converted. The development will also benefit from a substantial car park.

Planning

The site has full planning permission for residential development with a single retail unit/commercial at ground floor. The full planning application may be viewed on Nottingham City Council website (reference: 18/01382/PFUL3). The agents understand that there are no s.106 provisions and understand that planning permission has been implemented.

In addition the Vendor has drawn plans to enhance the development by the creation of an additional 14 apartments subject to planning.


