Location

The property is located in the central Market Place within Mansfield Town Centre. The town serves as a sub-regional centre of North West Nottinghamshire and is located approximately 14 miles north west of Nottingham, 13 miles south of Worksop and 12 miles south east of Chesterfield. The property is easily accessible via the A38 and A617, which in turn provide access to Junctions 28 & 29 of the M1.

Description

The property comprises 1st floor offices above an HSBC Bank, accessible off Leeming Street via personnel access/staircase. The property provides functional office accommodation, surrounded by a number of local amenities.
