This being 4.5% of the purchase price including VAT, subject to a minimum of £6,600.00 including VAT. The Reservation Fee is paid in addition to purchase price and will be considered as part of the chargeable consideration for the property in the calculation for stamp duty liability. Buyers will be required to go through an identification verification process with iamsold and provide proof of how the purchase would be funded. This property has a Buyer Information Pack which is a collection of documents in relation to the property. Kitchen: 19' 10" x 7' 5" (6.05m x 2.25m) having a range of fitted wall, drawer and base cupboard units with work surfaces over, inset sink and drainer unit, built in electric oven, plumbing for washing machine, double glazed window to the side, wall mounted boiler, uPVC door leading to the rear garden, radiator

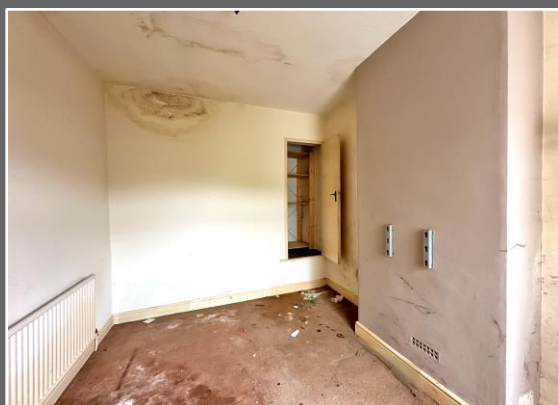

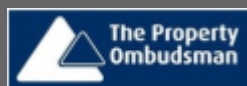
