BEDROOM

With wood-effect laminate flooring and double glazed windows overlooking the rear of the property. In the bedroom there is a door leading to the bathroom.

BATHROOM

With newly fitted white bathroom suite consisting of; bath with overhead shower, corner sink, and toilet.

LEASEHOLD

The property is leasehold. The leasehold is 125 years from 4 April 2016. A service charge and ground rent is payable and is currently £58PCM combined.

The Energy Performance (EPC) Rating for this property E. This property has been banded as Council Tax Band A.

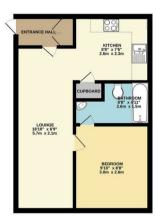
