#### 1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

#### **Neighbourhood and Location**

The subjects are situated in rural surroundings lying approximately 3 miles north east of Alness and 4 miles north of Invergordon. Immediate surrounding properties comprise scattered residential dwellings together with open countryside and woodland. There are open views to the front towards open fields, the Cromarty Firth and beyond. There is a range of local facilities and amenities available within nearby Invergordon and Alness whilst the city of Inverness is within commuting distance being approximately 28 miles south.

#### Weather

Dry.

#### **Chimney Stacks**

There are a large number of chimney stacks forming part of the property of pointed stone construction.

Visually inspected with the aid of binoculars where appropriate.

#### **Roofing including Roof Space**

The roof areas are of pitched design, clad with slates and incorporating lead ridging. There was some limited access gained to accessible roof void areas via ceiling hatches in the ground, first and second floors. Some fibreglass insulation was evident between ceiling joists.

Sloping roofs were visually inspected with the aid of binoculars where appropriate.

Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.

Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

#### **Rainwater Fittings**

The gutters and downpipes are predominantly of original painted cast iron construction with the exception of some replacement uPVC sections.

Visually inspected with the aid of binoculars where appropriate.

#### Garages and Permanent Outbuildings

There are a substantial amount of various outbuildings pertaining to the property.

There is an attached single storey rear projection which includes for a utility area and store with the outer walls being of solid stone construction under a lean-to slate clad roof.

There is a two storey attached projection which encompasses the metal fire escape stairs. The outer walls are of roughcasted block construction under a corrugated iron clad roof.

To the side of the dwelling house there is a detached double car garage comprising profiled metal walls and roof. Within this there is a storage area in the attic area.

To the rear of the dwelling house there is a detached annex building. The outer walls are predominantly of stone construction with the exception of a more modern roughcasted cavity brick/block projection to the rear. The roof areas are of pitched and hip-ended design and clad with slates. Within the annex there are three self contained units all of which have a living room/kitchen areas together with shower rooms.

In addition there are also a number of various stored/sheds and greenhouse.

Visually inspected.

#### **Outside Areas and Boundaries**

From information provided and from that obtained from an online mapping system the total site area is understood to extend to approximately 4 acres or thereby. We would however emphasise that no site measurements were taken at the date of our inspection. The land is predominantly laid with grass together with some paved sections. The boundaries where seen are formed in post and wire fencing.

There is a small water course feature at the northmost part of the site.

There are a number of large mature trees within the grounds.

Access to the subjects is taken from the main road with there being a tree lined private driveway providing access to the property. There are off street car parking areas to the front and side.

Visually inspected.

## Ceilings The ceilings are of lath and plaster type. There are some areas of timber cladding. Visually inspected from floor level.

## Internal Walls The internal walls are predominantly of lath and plaster type. There are some areas of internal timber panelling. Visually inspected from floor level. Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

Floors Including Sub-Floors	The flooring is of suspended timber construction although we would emphasise that our inspection of floor surface areas was restricted due to the presence of fitted floor coverings and furnishings.
	There was no access gained to any sub floor areas.
	Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

There are a number of modern dual fuel stoves within the property. A number of the former fireplaces have been boarded over and/or are no longer in use.	
Visually inspected. No testing of the flues or fittings was carried out.	
Internal decorations comprise wallpaper and painted finishes.

Mains supply. The electrical installation appears to comprise 13 amp power points whilst the cable where visible is of pvc clad type. There are a number of electrical consumer/RCD units in various parts of the property.

There is an LPG gas supply serving the property although the storage tank has been removed.

#### Water, Plumbing and Bathroom Fittings

Mains supply.

There are a number of bathroom and shower rooms within the property which are of mixed age and type.

There are also a number of fitted sinks within bedrooms.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

#### **Heating and Hot Water**

There is an LPG has fired boiler within an attached outbuilding which serves a number of water filled radiators within the property. We would however note that the LPG tank has been removed and this will require to be replaced in order for the central heating system to be functional.

There are a number of modern electric radiators within the Third floor.

There are a number of fireplaces and stoves within the property.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

#### Drainage

Drainage is understood to be via a private septic tank located within the boundaries.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

#### Fire, Smoke and Burglar Alarms

Confirmation should be sought as to whether a compliant smoke and heat alarm is installed.

There appears to be a fitted burglar alarm within the property.

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

#### **Additional limits to Inspection**

At the date of inspection the property was furnished whilst the floors were covered.

There was no access gained to any sub floor areas.

There was limited access only gained to roof void areas.

No services were tested during the course of our inspection.

Not all windows were tested during the course of our inspection.

A limited inspection only was undertaken of the garden grounds.

It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only.



Notes	Evidence of water ingress was noted as a result of roofing issues to the single storey rear projection.  See `dampness, rot & infestation` paragraph above. We would recommend that the roof areas be inspected by a reputable roofing contractor and any recommended repair
	works be carried out subject to long term guarantee.  The roof is of a complex design and all junctions/valleys are potential weak points. A regular repair and maintenance programme should therefore be envisaged and it would be prudent to have an annual inspection carried out.

#### 4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

#### Matters for a Solicitor or Licensed Conveyancer

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

Drainage, we understand is to an exclusive septic tank which we understand lies within the feu. This was not checked or tested. It should be ensured that appropriate registration documents are available.

We understand that the property was formerly a care home. Our valuation assumes that the property is now on a fully residential basis and can be occupied as such.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include some internal alterations together with the addition of the rear escape steps. In addition changes/alterations have been made to the rear annex building. We cannot confirm the age of the alterations carried out. On the balance of probability the alterations are likely to have been carried out in excess of 20 years ago.

It is assumed that the wood/multi fuel apparatus has been installed in accordance with the manufacturer's recommendations in particular regard to flueing and ventilation. The appliance was not tested.

We would recommend the full extent of grounds pertaining to the property be confirmed by reference to the title.



#### **Estimated Reinstatement Cost for Insurance Purposes**

£4,500,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.



The Seller will be entitled to cancel the inspection by notifying the Surveyor's office at any time before the day of the inspection.

#### **DESCRIPTION OF THE REPORT**

#### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

#### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

#### 2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

#### 2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

#### 2.3.2 Category 2:

Repairs or replacement requiring future attention, but estimates are still advised.

#### 2.3.3 Category 1:

No immediate action or repair is needed.

#### WARNING:

If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. The existence of Category 2 or Category 3 repairs may have an adverse effect on marketability, value and the sale price ultimately achieved for the Property. #### 2.5 Accessibility

A section is included to help identify the basic information interested parties need to know to decide whether to view a Property.

#### 2.6 Energy Report

A section is included that makes provision for an Energy Report, relative to the Property. The Surveyor will collect physical data from the Property and provide such data in a format required by an accredited energy company. The Surveyor cannot of course accept liability for any advice given by the energy company.

#### 2.7 Valuation & Conveyancer Issues

The last section of the Report contains matters considered relevant to the conveyancer (solicitor). It also contains the Surveyor's opinion both of the market value of the Property and of the re-instatement cost, as defined below.

"Market Value" is the estimated amount for which a property should exchange on the date of valuation within a willing buyer and willing seller in an arms-length transaction after proper marketing wherein the parties have each acted knowledgably, prudently and without compulsion. 





#### The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. #### 1 Room-in-roof insulation

Insulating roof rooms will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. If it has a flat ceiling insulation can usually be added above the ceiling, and sloping ceilings and walls of roof rooms can be insulated using an internal lining board. Roof voids must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about roof room insulation and details of local contractors can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). Building regulations generally apply to this work so it is best to check this with your local authority building standards department.

#### 2 Internal or external wall insulation

Internal or external wall insulation involves adding a layer of insulation to either the inside or the outside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. External solid wall insulation is the application of an insulant and a weather-protective finish to the outside of the wall. This may improve the look of the home, particularly where existing brickwork or rendering is poor, and will provide long-lasting weather protection. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). It should be noted that a building warrant is required for the installation of external wall insulation. Planning permission may also be required and that building regulations apply to external insulation so it is best to check with your local authority on both issues.

#### 3 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

#### 4 Draughtproofing

Fitting draughtproofing, strips of insulation around windows and doors, will improve the comfort in the home. A contractor can be employed but draughtproofing can be installed by a competent DIY enthusiast.

#### 5 Condensing boiler

A condensing boiler is capable of much higher efficiencies than other types of boiler, meaning it will burn less fuel to heat this property. This improvement is most appropriate when the existing central heating boiler needs repair or replacement, however there may be exceptional circumstances making this impractical. Condensing boilers need a drain for the condensate which limits their location; remember this when considering remodelling the room containing the existing boiler even if the latter is to be retained for the time being (for example a kitchen makeover). Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

#### 6 Double glazed windows

Double glazing is the term given to a system where two panes of glass are made up into a sealed unit. Replacing existing single-glazed windows with double-glazed windows will improve comfort in the home by reducing draughts and cold spots near windows. Double-glazed windows may also reduce noise, improve security and combat problems with condensation. Building regulations apply to this work and planning permission may also be required, so it is best to check with your local authority on what standards need to be met. A building warrant is not required if the windows comply with the current requirements.

#### 7 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

#### 8 Wind turbine

A wind turbine provides electricity from wind energy. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Wind turbines are not suitable for all properties.
