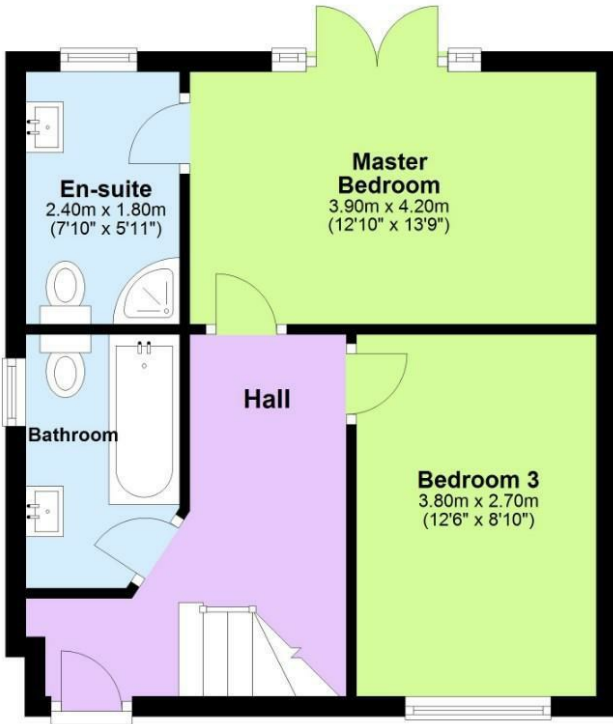

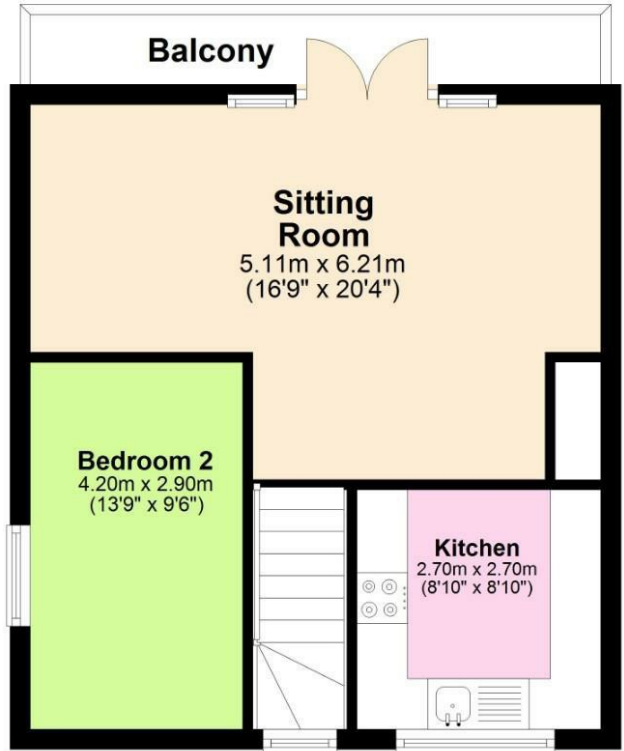

Floor Plan

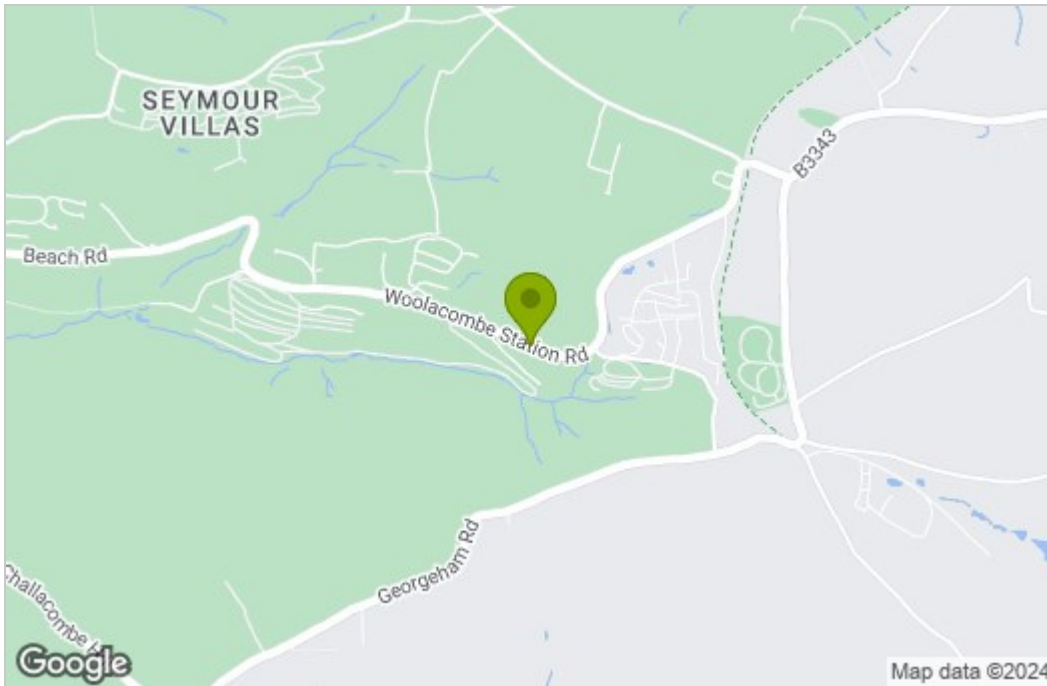
Ground Floor



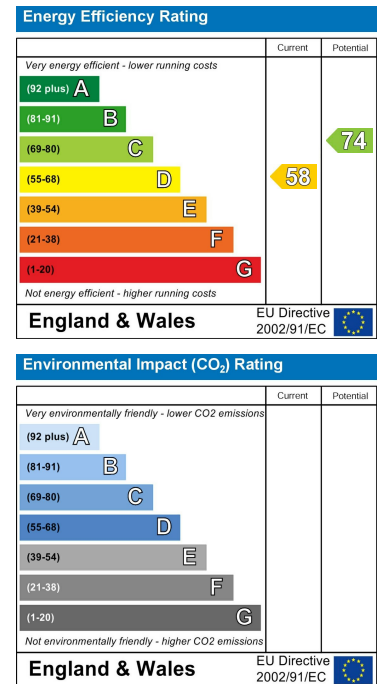
First Floor
