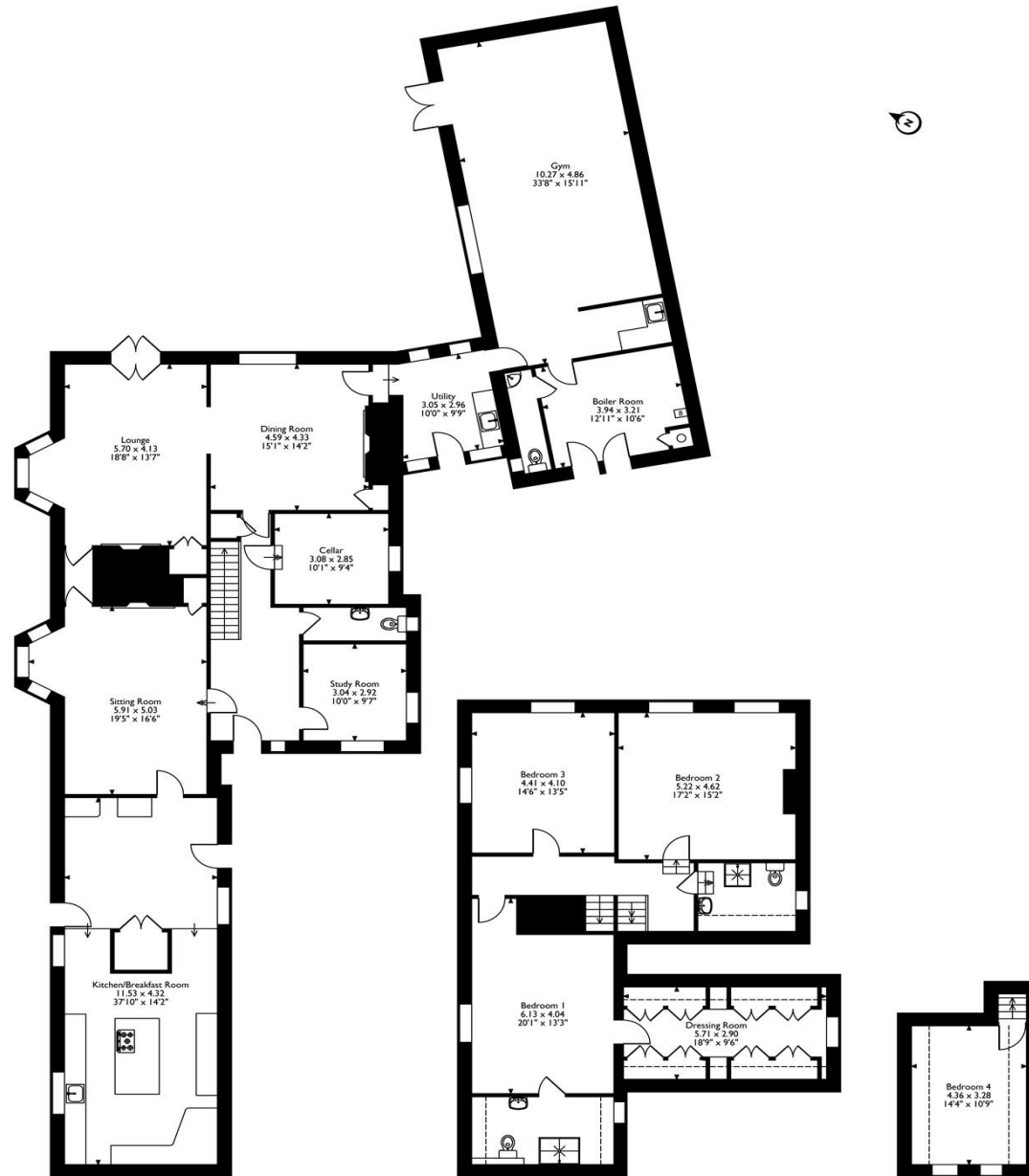
This charming three storey listed thatched palatial home offers a wealth of character combined with the benefits of modern living.
