Auction Process & Fees:

The property will be offered for sale by Online Traditional Auction (unless sold prior). The auction end date is **19:00hrs on Friday 2nd August 2024**. The vendor reserves the right to withdraw or alter the property for sale prior to the auction end date.

Buyer Fees/Payments:

The successful purchaser(s) will be liable to pay the sum of £5,000 at the end of the auction. 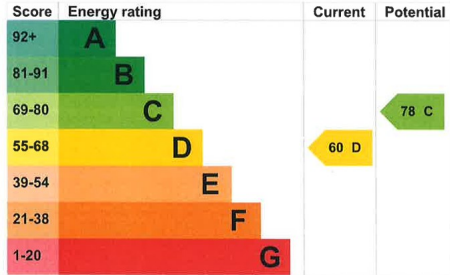

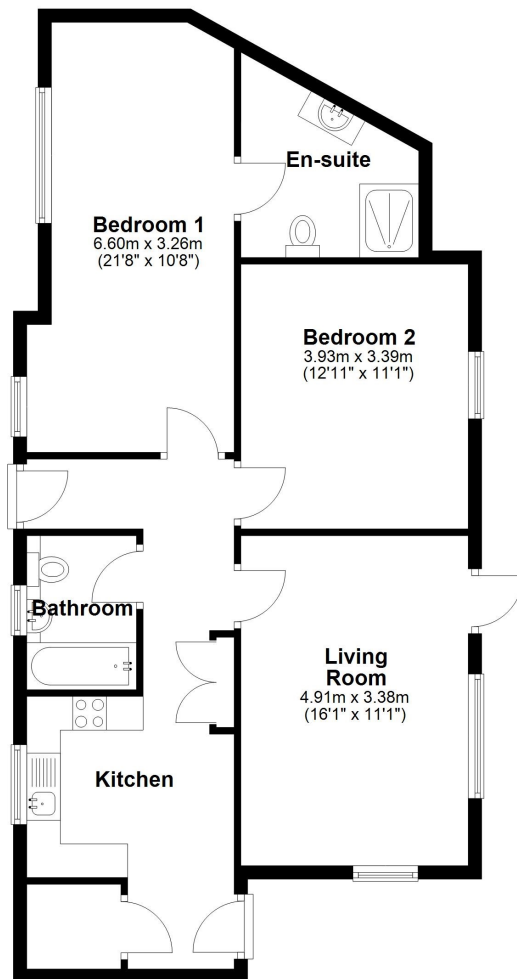
