Presented immaculately throughout, the principle layout of the house is classically arranged with the kitchen and dining room on the ground floor, formal reception room on the first floor and principle bedroom suite on the second floor. There are three further bedroom suites and two staff bedrooms and bathroom. The top floor is currently arranged as a media room but could easily be converted into a two bedroom suite subject to the usual consents. The lower floors of the house are put to very good use with a dedicated gym, complete with steam room and sauna, a treatment room, swimming pool and jacuzzi. The property benefits from air conditioning throughout and a lift which runs from the basement to the fourth floor, and is rare for a Chester Square house.
