#### **Property Description:**

Covering 3,430 square feet, this freehold property, one of two 'key houses' on the North side of Wilton Street, is presented in very good condition throughout. It offers flexible accommodation, including the opportunity to arrange the lower ground floor as a separate self-contained apartment (subject to the relevant consents).

Principle accommodation is arranged with a study / sitting room, kitchen / breakfast room and dining room on the ground floor, formal reception room on the first floor, principle bedroom suite on the second floor and three further bedrooms and shared bathroom on the upper floor.

The basement is currently arranged with two bedrooms suites, utility / kitchen, garden room and a patio.

Of particular note is the dining room, which is on the ground floor and occupies the full width of the house. The first floor drawing room has very generous proportions and floor to ceiling windows, with doors leading onto a roof terrace, which benefits from afternoon and evening sun.






