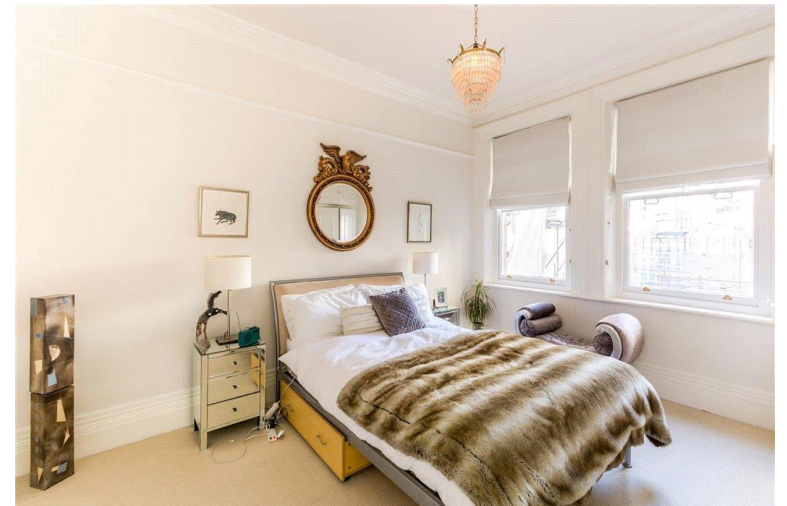

### Location

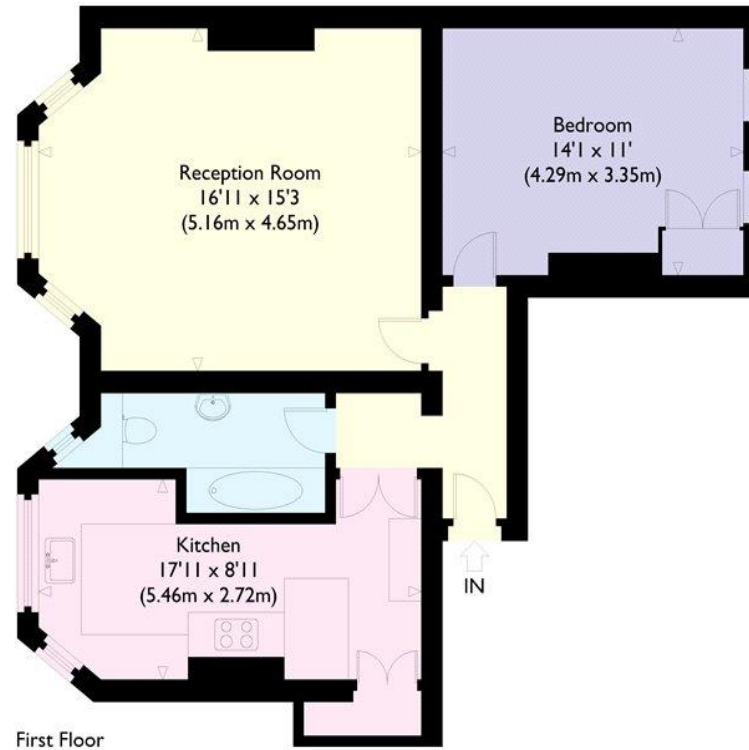
Buckingham Gate is located within close proximity to the green open spaces of St James's Park and Green Park.
