

LOCATION	• Sale town centre is located approximately 0.5miles to the south.		
	<ul> <li>Manchester City Centre is located 5 miles to the south west.</li> </ul>		
	<ul> <li>The property fronts onto Cross Street which connects to the M60 motorway and is the main arterial route from Manchester to Altrincham.</li> </ul>		
	Vehicular access to the site is taken from Denmark Road.		
	<ul> <li>The immediate vicinity of the site is mixed use in nature, with the various commercial uses along Cross Street and residential</li> </ul>

TITLE	• There are two freehold titles associated with the site, both owned by London & Quandrant Housing Trust, under GM542696 and GM559178.		
PLANNING	• The site is located within the jurisdiction of Trafford Brough Council.		
	• The revised Trafford Unitary Development Plan identifies the property as part of a larger allocation, "large site released for housing development (H3)" capable of accommodating 30 dwellings.
