LOCATION

The unit is situated on Albert Close, which is just off Moss Lane in Whitefield. The property is within 300 yards of the A56, Bury New Road, which provides direct access to Junction 17 of the M60 Motorway.

Manchester City Centre is approximately 5 miles South and Bury Town Centre is approximately 4 miles to the North.

The unit is within a secure gated development in a long-established industrial area.

DESCRIPTION

The unit is steel portal framed in construction, with a concrete floor and LED bay lighting. The property has a pitched roof with a rolling height of 3.5m to 5m. The roof is asbestos cement which has been overlaid with steel profile sheeting with the benefit of solar panels.

To the front there is a recently refurbished office with the benefit of tiled floor, electric wall heating, LED lighting and wc's.

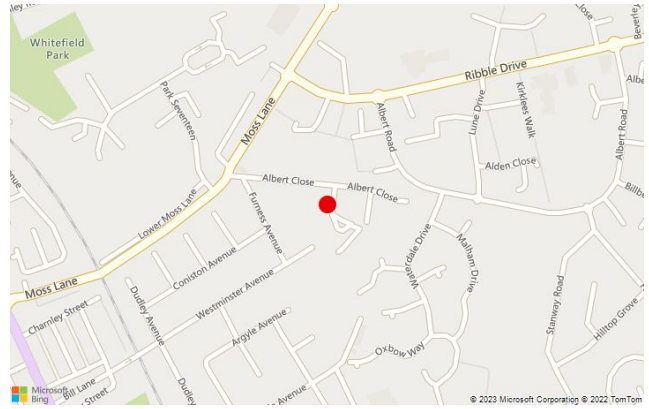
