

The units are offered in shell and core with glazed shop fronts. The height of each unit is over 5.8 metres potentially allowing a mezzanine floor to be installed, subject to consent.

Services are capped with 3 phase electric supply and water supply. A loading bay is also based outside the units allowing easy access into the unit.

The units currently have consent for the E class use. They are also available immediately.

#### Location

The units are adjacent to Gallions Reach DLR station which provides links into The Docklands, the City and Stratford via Canning Town. Its also just 7 minutes away from the Crossrail station at Custom House. City Airport is also close by. The area itself is benefiting from large redevelopment with hundreds of flats being constructed as part of the Gallions Point scheme and another opposite creating a

vibrant scene in and around the local vicinity.


