The site is situated on Stratford High Street, there is a cycle lane between the land and the high street which restricts vehicle access, however its central location makes it highly accessible for pedestrians. The site is predominantly a combination of soft soil and concrete pads. The site is suitable for a variety uses, the landlord is open to reviewing various planning proposals.

Location

The site is located in Stratford, less than 1 mile from the Town Centre and main station. Access onto the Central, Jubilee, Queen Elizabeth, DLR, Overground and National Rail is all possible from Stratford Station. There is also the Stratford High Street DLR only a few minutes walk away.
