For the sake of the house 1 & 2 should be felled.</p> <p>3 Is a christmas tree, planted about 50 years ago and is very close to the house. If permission is given to remove 1 & 2, we would assess 3 afterwards. This may need to be felled.</p> <p>4 & 5 Yew trees used to be kept to about 2.4metres. these have not been cut for 7-8 years. permission to return to original height.</p> <p>6 Group of Norwegian Spruce. About 40 of them were planted about 40 years ago. The trees are about 10 - 15 meters tall and block light to the fruit trees. We would like to remove a selected few, some are too close to others and a few to let more light to the fruit trees. About 15%. 6 or 7 trees.</p>
