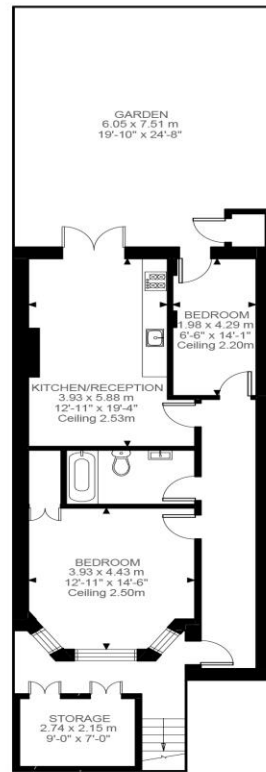

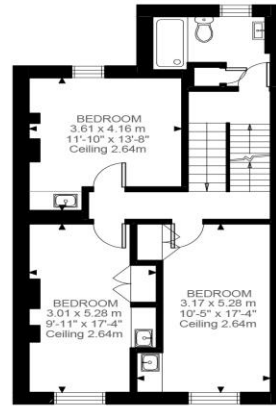

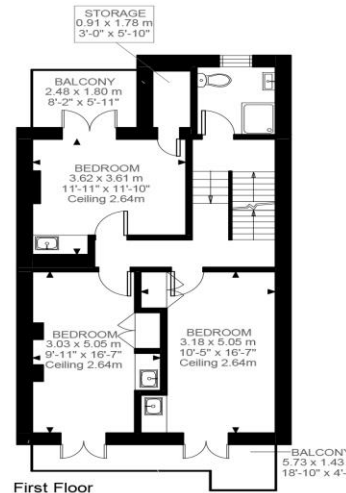
Second Floor
