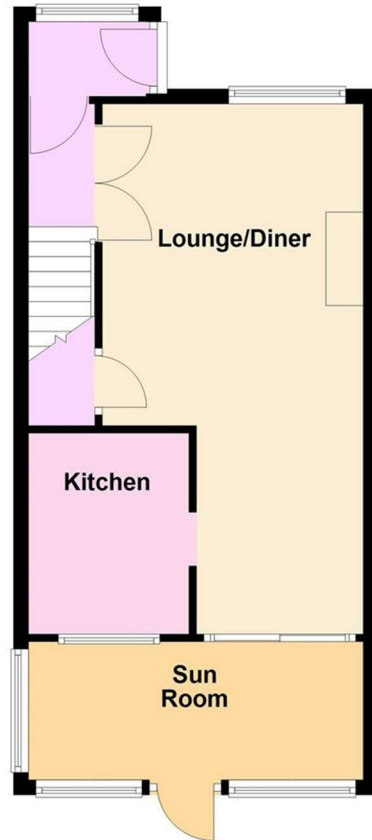

Floor Plan Lychpole Walk

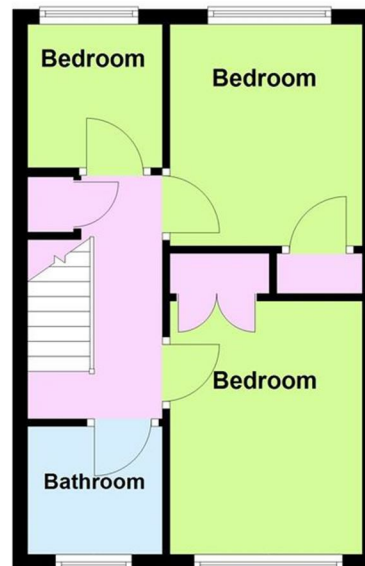
