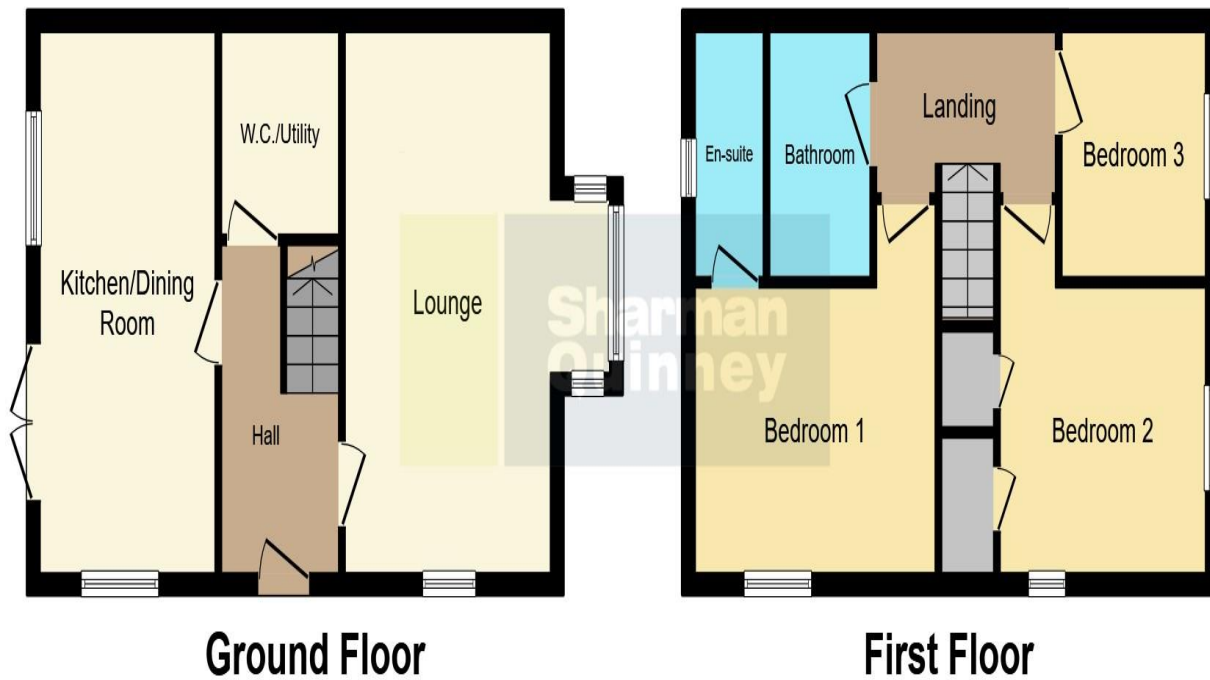
Rear
