

This beautifully presented home has sympathetically been improved, with entrance lobby extending to both the dual aspect reception sitting room and the modern, yet in character wellappointed kitchen. The shaker style modern fitted cabinetry is complimented by solid timber work surfaces and a traditional deep Belfast sink. Featuring an array of integrated appliances including washing machine/ tumble dryer combination, dishwasher, fridge and freezer, eye level fitted oven and microwave oven and electric induction hob.







The kitchen extends to comfortable dining area suitable for a good-sized table and the space features further practical storage with larder/cupboards and built in shelving. The first-floor accommodation is accessed via an enclosed staircase with timber latch style door leading to a spacious landing/ anteroom, with fitted wardrobes and access to a generous loft space. Double bedroom - A spacious bathroom comprises an oversize shower enclosure (three piece suite)

The property benefits from full double glazing within character high specification sash windows with Georgian bar design and Gas fired to radiator central heating.
