


Northfield Avenue, Ringstead Kettering £350.000 Freehold

The front garden is of good size, which is mainly laid to lawn, driveway providing off road parking for a number of vehicles. A detached tandem length double garage with up and over door measuring 27' x 7' 7" (8.23m x 2.35m)

The rear garden offers a good deal of privacy, with the majority of the garden laid to lawn, there is also an area which has been planted with an abundance of shrubs/bushes and mature rhubarb plants. Located just behind the garage is a paved patio area, courtesy door leading to garage. The garden benefits from enjoying a south easterly aspect.
