Location

The estate is ideally situated in a prime trade/retail location on the Western side of Cardiff. Penarth Road is one of the main arterial routes with excellent road connectivity to the city centre and to Cardiff Bay and M4 (J33) via the PDR A4232. Tollgate Close benefits from frontage and direct access from Penarth Road with National Tyres Auto Centre located at the entrance. Other occupiers on the Estate and the surrounding area include Screwfix, HSS, Dreams, Scania, and Edmundson Electrical.
