

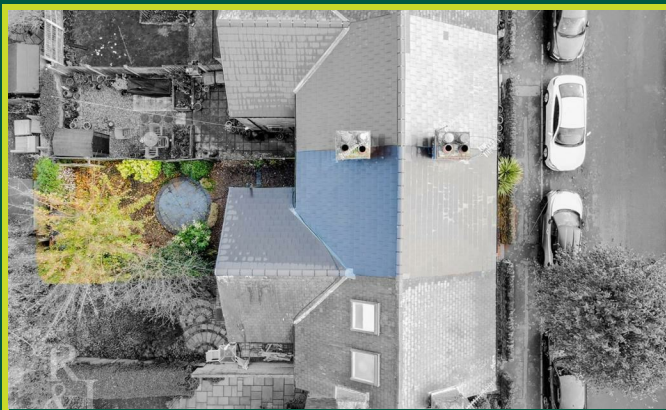

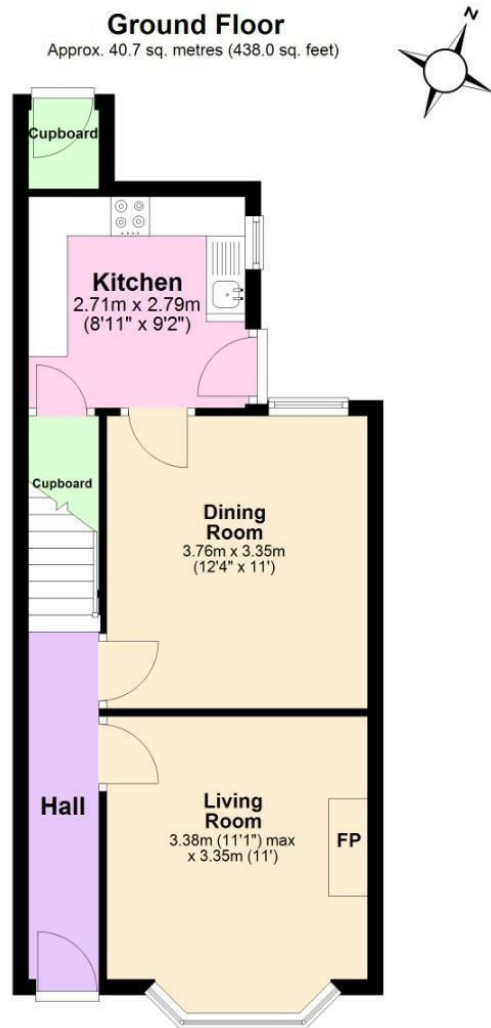
Royston and Lund are delighted to bring to the market this two bedroom mid terrace property located in the heart of West Bridgford. Situated a short walk from Melton Road shops and Central Avenue where there are pubs, restaurants and cafes, not to mention having excellent transport links into the City Centre. This property would be a great fit for a growing family or first time buyers.

Ground floor accommodation comprises of an entrance hall that leads into the main reception rooms and stairs to the first floor. The living room is a generous size with a front aspect bay window flooding the room with natural light, pieced together with a period correct fireplace. The dining room is ample in size with more than enough room to accommodate family and friends. Off from the dining room you enter the kitchen which boasts integrated appliances such as an oven hob and extractor fan, electrics for a freestanding washing machine along with further room to add freestanding appliances. The kitchen additionally has under stair storage and side door leading to the rear garden.

To the first floor there are two well proportioned double bedrooms that both have period fireplaces and share a spacious three piece suite bathroom comprising of a bath with shower overhead along with a wash basin and WC.

Facing the property there is on street parking and to the rear there is a low maintenance courtyard/garden with patio areas and pebble flower beds along with convenient storage sheds and a bricked store located to the back of the kitchen. The rear courtyard is enclosed by fenced borders.
