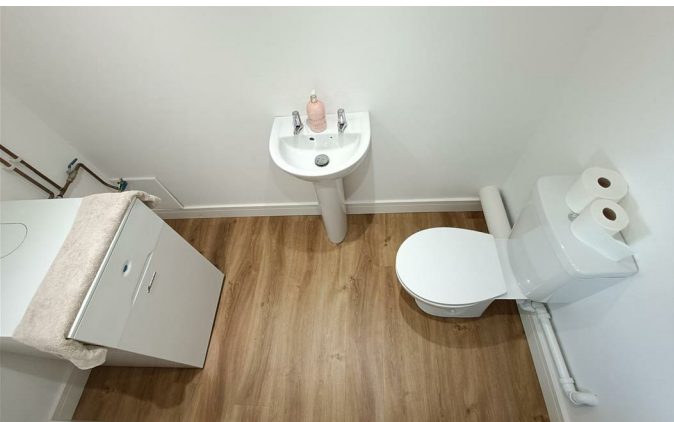
To the first floor are larger than average family bathroom with frees standing shower, two large double bedrooms with built in storage.
