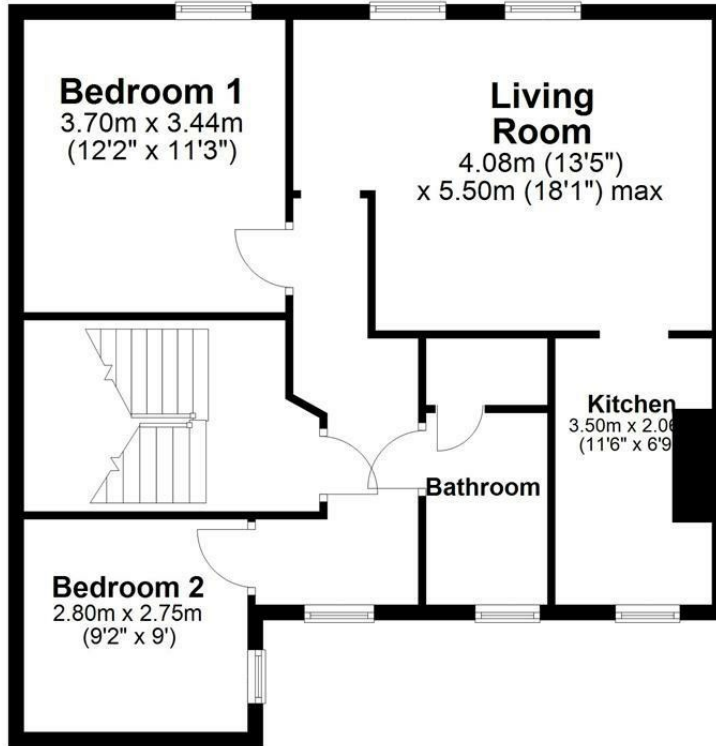
Legal Pack
