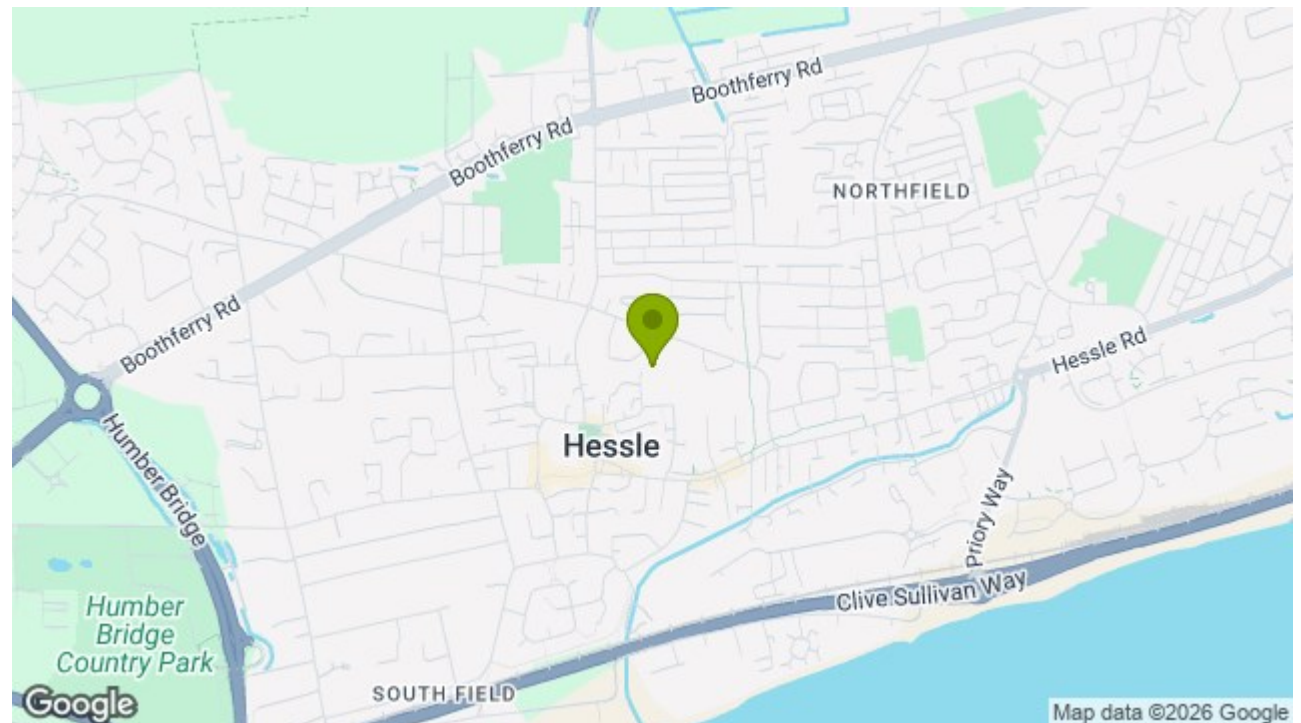

ENTRANCE HALL

With staircase leading to the accommodation.

FIRST FLOOR;

LIVING ROOM

A generous living space with bay window to the rear elevation.
