



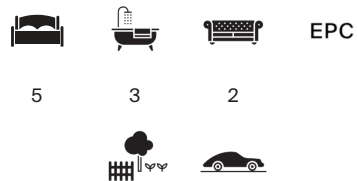

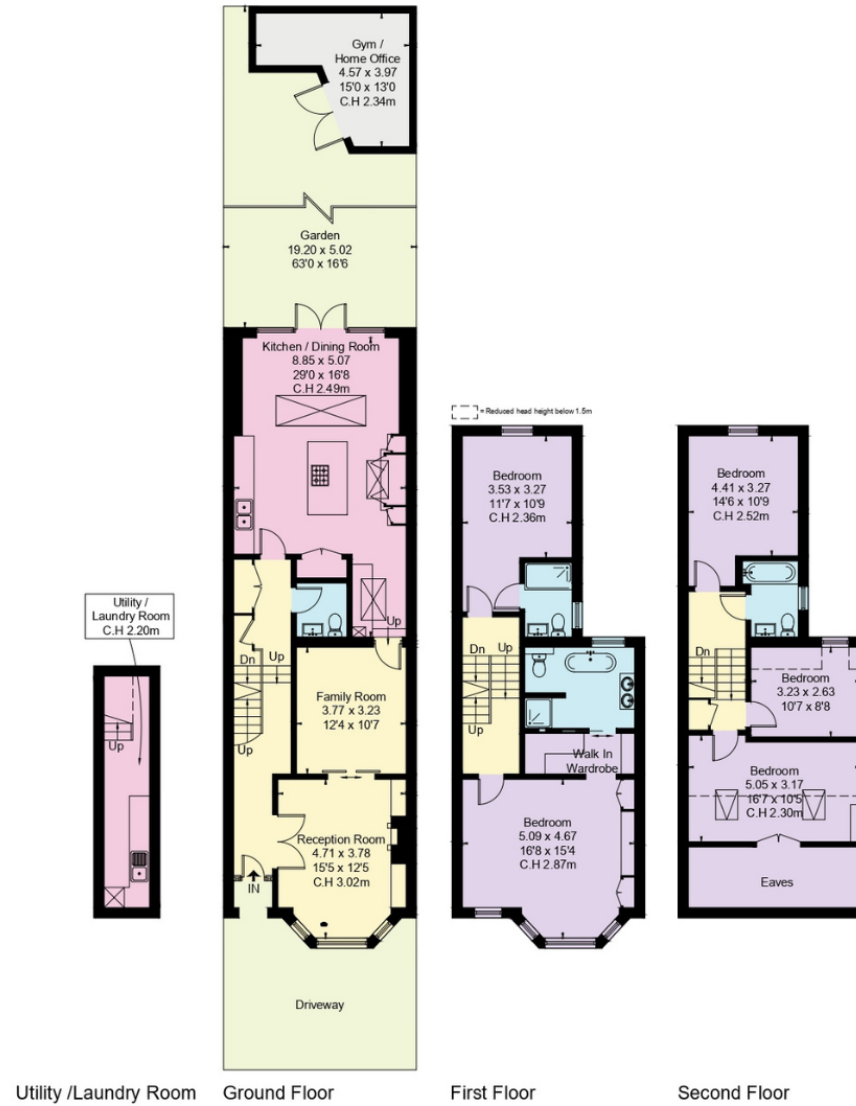
## A BEAUTIFUL, TURNKEY FAMILY HOME IN WANDSWORTH

Set on Hendham Road, this fully renovated five-bedroom, three-bathroom period home offers around 2,500 sq ft of bright, beautifully finished space across three floors. The property includes off-road parking (wired for EV charging) and a stylish entrance hall. The bay-fronted reception room features oak flooring, an original marble fireplace and bespoke cabinetry, leading to a second snug. At the rear, the open-plan kitchen/dining room includes a shaker kitchen with marble worktops, large island, premium integrated appliances and doors opening to the landscaped south-facing garden. A WC and access to the lower-ground utility complete the ground floor. The first floor features a full-width principal suite with dressing room and luxury en-suite, plus a guest bedroom with en-suite. The top floor offers three further bedrooms and a modern family bathroom. The south-facing garden is professionally landscaped with year-round planting, irrigation and integrated lighting, creating an inviting, low-maintenance space.
