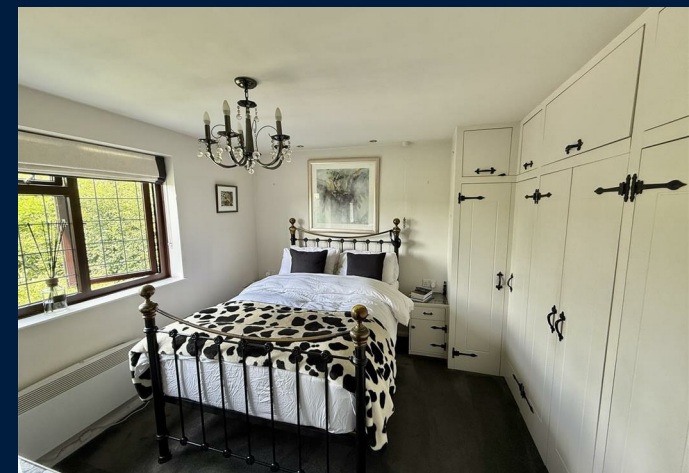

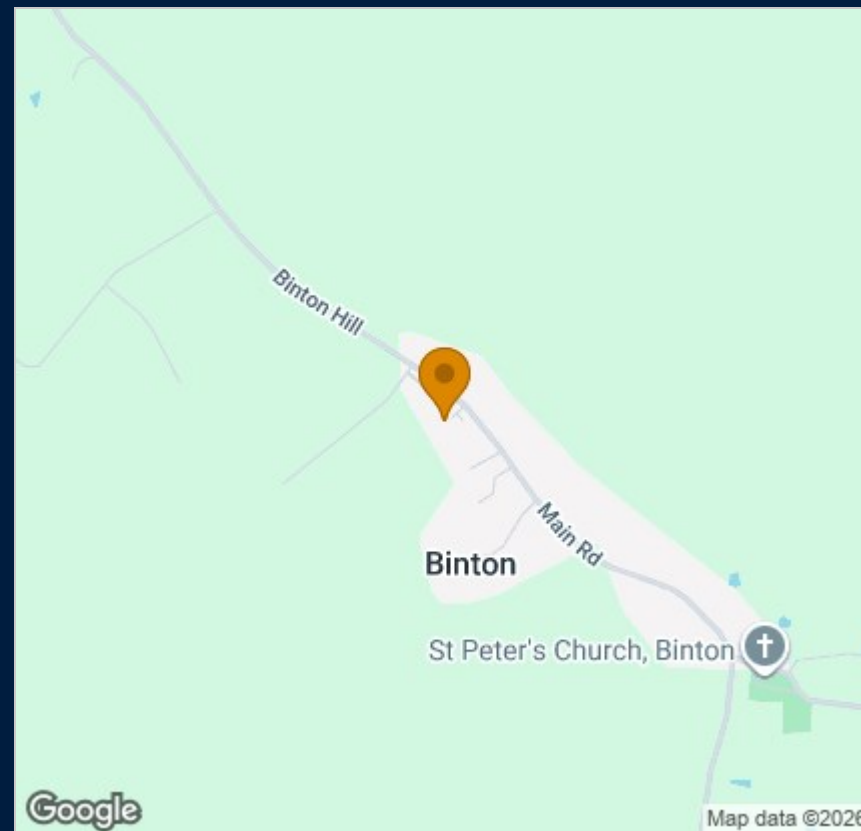

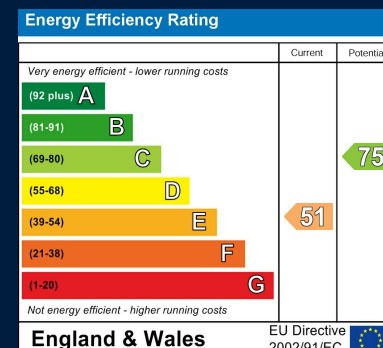
Floor Plan
