



LOCATION:

Gamlin Close is located on the Longforth View development ideally placed on the outskirts of Wellington yet still within walking distance of the town centre. The property itself enjoys open space to the front and side with plenty of countryside walks nearby. Wellington is a popular market town boasting an assortment of both independently run shops and larger national stores to include the well renowned Waitrose whilst also benefitting from a range of educational and leisure facilities a Sport Centre, cinema and The Cleve Hotel & Spa. The landmark Wellington Monument showcases extensive views across the Blackdown Hills which is an Area of Outstanding Natural Beauty. There is also a regular bus service to outlying villages and to the County Town of Taunton which is approximately 7 miles distant with its main line railway station. The M5 Motorway can be accessed via Junction 26 just outside Wellington.

DIRECTIONS:

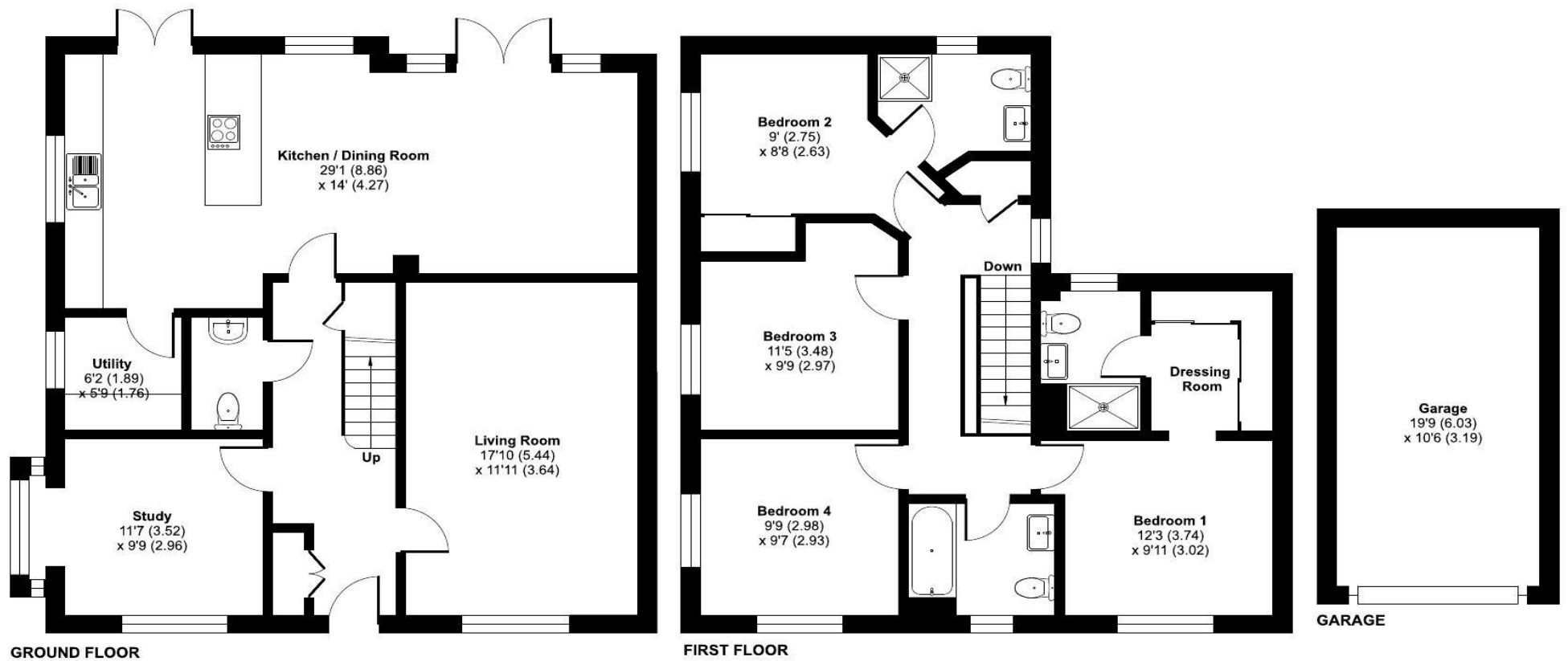

This four bedroom executive style detached house was built by Bloor Homes in 2020 to 'The Osterley' design and benefits from the remainder of its 10 year builder's warranty. The property has been lovingly cared for since new by the current owners and offers an opportunity for an incoming buyer to move straight in.

The accommodation on offer briefly comprises; front door opens into the entrance hallway with stairs rising and turning to the first floor and doors to the principal rooms. The sitting room is a generous size with a window to the front elevation and ample space for furnishings. Spanning the width at the rear of the house is a large kitchen/dining/family room which is clearly the highlight of the property. The kitchen itself is fitted with a comprehensive range of modern wall and base units with integrated appliances and continues through to the adjoining utility room. French doors open from the dining/family area to the rear garden.

Completing the ground floor is a second reception room alongside a useful cloakroom.

To the first floor there are four well proportioned bedrooms, with the two largest having the added benefit of en-suite facilities, alongside a dressing area to the master. The family bathroom is fitted with a three piece suite with a shower over the bath.

Externally, the property occupies a corner plot with a garage and off road parking for two vehicles. The main garden is situated at the rear and is predominantly laid to lawn with a pergola over a patio area adjacent to the house.
