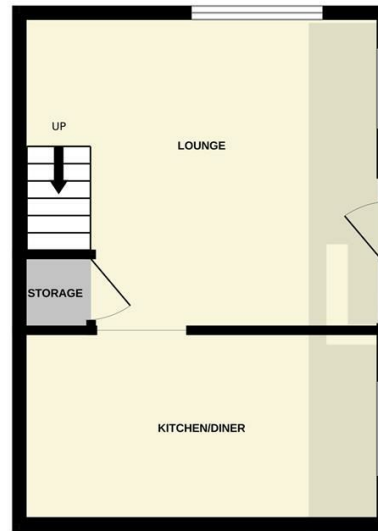
Referral Fees.

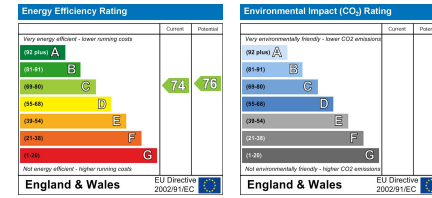
