A beautifully presented three-bedroom semi-detached property situated on Vicarage Road, Stourbridge, which has recently undergone a full refurbishment throughout, offering a fantastic opportunity for buyers seeking a stylish, move-in-ready home.

The property benefits from no upward chain and enjoys attractive views to the rear, adding to its appeal. To the front is a spacious driveway providing ample off-road parking, while internally the accommodation briefly comprises a welcoming lounge, separate dining room and a newly refurbished kitchen.

To the first floor are three well-proportioned bedrooms and a modern shower room. Outside, the property further benefits from a low maintenance courtyard style garden to the rear.

Having been comprehensively refurbished throughout, this property is ideally suited to first-time buyers, families or investors looking for a property requiring little or no further work. Early viewing is highly recommended.

Door to front and stairs off.

Dining Room

Double glazed window to front, central heating radiator and cupboard off.

Double glazed window to front and rear and central heating radiator.

Kitchen

Double glazed window to side, door to rear, range of wall and base units with work surface over incorporating sink with mixer tap, electric hob with extractor hood over, oven, central heating radiator, space and plumbing for washing machine.

Referral Fees.

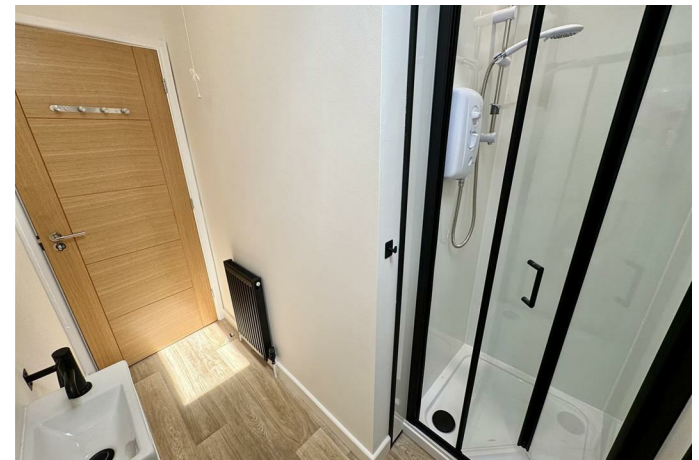
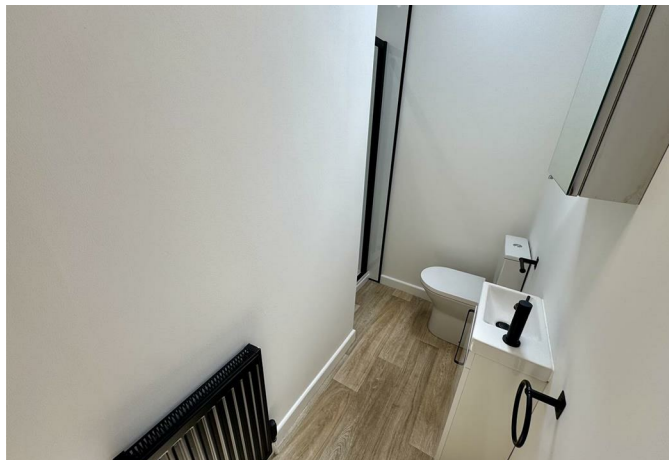

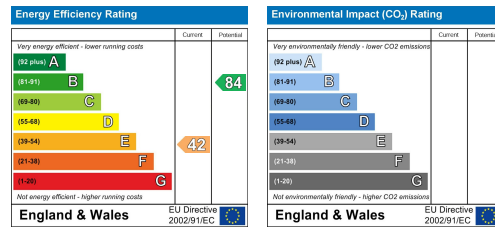
